Professor Craighead's career has centered on generating knowledge about how to increase supply chain effectiveness, disseminating that knowledge through multiple channels, and elevating people and organizations in the process.

His primary research interest has focused on how to recover from disruptive events in the supply chain. Within this realm, he has published highly influential papers that have shaped the related body of knowledge. For example, his co-authored paper "The Severity of Supply Chain Disruptions: Design Characteristics and Mitigation Capabilities" was recognized as the #3 Most Downloaded Paper and the #10 Most Cited Paper in *Decision Sciences Journal's* 50-year history. A critical theme in his research is service recovery, whereby companies must overcome performance failures to retain customers (e.g., companies, consumers).

The very nature of how supply chains compete is evolving – Professor Craighead's research has also pivoted. Specifically, his more recent research examines the supply chain-entrepreneurship interface. For example, his co-authored paper moves towards a new theory – *Supply Chain Entrepreneurial Embeddedness* – that prescribes how companies can inject entrepreneurial capabilities into their supply chain as a means of competing in normal and disrupted states.

Professor Craighead emphasizes roles in which he can elevate others' scholarship. He has received multiple awards for editing excellence from *Decision Sciences*, *Journal of Business Logistics*, *Journal of Operations Management* and *Journal of Supply Chain Management*. Professor Craighead has served as the Director of the Supply Chain Management PhD Program at both the University of Tennessee and Pennsylvania State University, where he led efforts to refresh the programs to better fit academic job market demands and evolving research expectations. He has been a dissertation chair for seven PhD students across three universities and spends considerable effort mentoring junior faculty members. In doing so, he enjoys and excels at teaching the "research craft" necessary to publish in top supply chain journals. For example, since 2015 (year he joined UT), he has published 24 papers with 18 of them involving PhD students and/or junior faculty.

Professor Craighead effectively bridges academia and industry. For example, his research has fueled over 430 executive education programs, which have, in turn, enriched his teaching. At Penn State, he worked as the Director of Research of the Center for Supply Chain Research, where he served as the principal liaison between faculty and industry partners. By bridging academia and industry, Professor Craighead's career has culminated in both theoretical and pragmatic impacts. He has been a strong advocate for such a career strategy, co-authoring papers geared toward helping others in the field realize this dual impact.


